## Adoption Agreement/Health Guarantee

Thank you for deciding to adopt one of our puppies. We want to make this a stress-free, enjoyable experience for you. Please feel free to email or call us with any questions or concerns that you might have along the way. This contract is written for the protection of both the breeder and the buyer - However, it is primarily written to protect the health and general wellbeing of the puppy.

## Adoption Agreement—Purchase Price: \$

1. Please read this document completely before putting a deposit on a puppy. By placing a deposit, you are agreeing to the terms and conditions within this contract, and the Adoption Process listed at CnKCBoxers.com

- 2. A Non-Refundable \$400.00 Pup-care Expense Fee ("deposit") will hold an available puppy
- 3. Final Payment to be made in cash only
- 4. Any exceptions must be made in writing-verbal exceptions to the contract are not valid

## Health Guarantee—All sales final, with exceptions listed below:

- 1. Breeders will set delivery date; around eight weeks based upon the weight of the puppy, how easily it is weaned from the mother, and not before their final health check
- 2. The puppy is guaranteed to be in good health at the time of sale
- 3. The puppy will receive an initial vet check, dew claws removal, tail dock, first shots, worming, and a final health check before delivery
- 4. Pup must be picked up by the due date, given by the breeder. Daily fees will accrue unless arrangements have been made due to unforeseen circumstances
- 5. The buyer, at their own expense, should have the puppy examined by a Licensed Veterinarian as soon as possible after receiving the puppy
- 6. If upon first vet visit, a Licensed Vet finds the puppy to be unhealthy, it may be returned for a full refund upon the concurrence of the seller's vet—provided the puppy has no signs of injury or neglect. The buyer's veterinarian must provide a written statement deeming the puppy "was unhealthy for purchase at the time of sale", with a proper justification for such. The owner must also allow for the Breeder's vet to re-examine the dog (at the cost of the new owner) and the two doctors must agree that the pup was not healthy at its final vet check before an exchange will take place. \*This offer is null and void if first vet visit takes place more than 30 days after pick up date.
- 7. This guarantee does not cover any health issues caused by neglect or injury, or minor illnesses and health issues such as colds, allergies, internal or external parasites or umbilical hernias
- 8. Breeder will not assume any further responsibility for puppy after pick-up, unless the pup is found to be unfit for sale as described in #6
  - a. Breeder assumes no responsibility for any medical expenses incurred after delivery
  - b. Breeder assumes no responsibility for training difficulties or behavior problems
  - c. Breeder does not guarantee size, temperament, fertility, or the ability to place in shows
- 9. Breeder does not do genetic testing on adults or pups
- 10. Puppy is being sold and purchased with the understanding that it is a household pet
